Pretecs Sandwich facade connection PDM is used to connect the outer layer to the inner layer of concrete sandwich panel and thereby transferring loads caused by deadweight, wind and temperature. The product consist of a diagonal stainless steel wire welded onto an outer and inner wire of reinforcement bar.

Pretec sandwich façade connection system PDM are CE-marked according to EN 1090-1.

Cut-off criteria:

All major raw materials and all the essential energy is included. The production processes for raw materials and energy flows with very small amounts (less than 1%) are not included. These cut-off criteria do not apply for hazardous materials and substances.

Allocation

The allocation is made in accordance with the provisions of EN 15804. Incoming energy and water and waste production in-house is allocated equally among all products through mass allocation. Effects of primary production of recycled materials is allocated to the main product in which the material was used. The recycling process and transportation of the material is allocated to this analysis.

Data quality:

Specific data for the product composition are provided by the manufacturer. The data represent the production of the declared product and were collected for EPD development in the year of study. Background data is based on EPDs according to EN 15804 and different LCA databases. The data quality of the raw materials in A1 is presented in the table below.


